AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Pool operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Water and Sewer Risk Management Pool from November 1, 2016 through October 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Pool's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended October 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Compliance with risk pool solvency requirements
- Payroll review of calculation of leave buyout
- Claims payments review
- Credit card transactions compliance with Pool policy and procedures

INFORMATION ABOUT THE POOL

The Water and Sewer Insurance Pool, doing business as Water and Sewer Risk Management Pool, was established in November 1987 to provide a modified self-insurance program to member water and sewer districts. The Pool provides insurance protection and seeks to prevent or reduce property and casualty losses and injuries to people and property, which might result in claims against the members of the Pool. Approximately 61 member districts participate in the Pool.

The Pool had three full-time employees in 2017 and annual operating expenses of approximately \$2.3 million. The Board of Directors, composed of one designated representative from each participating member, governs the Pool. The Executive Committee consists of seven members elected by the membership, in alternating election cycles, at the March semi-annual meeting. The Executive Committee is responsible for conducting the business affairs of the Pool.
