#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, except as described below, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to City management and Council in a letter dated July 3, 2018, related to the use of a purchasing cooperative. We appreciate the City's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the City of Kelso from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Police Department evidence room, disposition of property, confidential funds, contract compliance for resource officer, citation reconciliations, and tracking of armory equipment and confidential funds
- Payroll with a focus on overtime for police and public works employees
- Use of restricted funds
- Procurement public works, purchases, and architectural and engineering services
- Contract compliance for public works projects retainage and prevailing wages
- Disbursements credit cards, travel reimbursements and general vendor payments
- Third party cash receipting of the Retail Lockbox agreement

## INFORMATION ABOUT THE CITY

The City of Kelso serves approximately 11,980 citizens. The City provides services including police, streets, sanitation, recreation, library, public improvements, planning and zoning, water supply treatment and distribution, and sewage and storm-water collection and treatment.

An elected, seven-member Council governs the City. The Council selects a Mayor from among its members to serve a two-year term. The Council appoints a Manager to oversee the City's day-to-day operations as well as its 79 employees. For fiscal year 2017, the City operated on an annual budget of approximately \$41.7 million.
