AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, except as described below, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to City management and councilmembers in a letter dated July 3, 2018, related to consultant services contract, state and city business and occupation taxes, and state business licenses. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Snoqualmie from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Compliance with refunded bond
- Financial condition
- Procurement compliance with public works project awarded for Emergency generator for the sewer treatment facility
- Payroll support for police overtime
- Citizen Hotline referral Review of consultant services contract and payments
- Citizen Hotline referral Review of vendor activities and services
- Citizen Hotline Referral I-9 form completion

- Citizen Hotline Referral Compliance with city and state business and occupation tax
- Citizen Hotline Referral Business license permit review

INFORMATION ABOUT THE CITY

The City of Snoqualmie is located in eastern King County and serves approximately 13,100 residents. The City provides services including police, fire, public works, water and sewer utilities, building, planning and parks and recreation. It also provides police services to the neighboring City of North Bend.

An elected, seven-member Council and an independently elected Mayor govern the City. Council Members and the Mayor serve staggered, four-year terms. The Mayor appoints management to oversee the City's daily operations as well as its 115 employees. For fiscal year 2016, the City's budget was approximately \$76 million.
