AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, except as described below, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Directors in a letter dated July 11, 2018, related to the Associated Student Body. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Kittitas School District No. 403 from September 1, 2015 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll supplemental contracts and incentive pay
- Enrollment student reporting at the high school
- Selected IT security policies, procedures, practices, and controls protecting financial systems, IT systems, and data
- Cash receipting at the District Office
- Associated Student Body accounting, cash receipting, fundraising and disbursements at the secondary school
- Disbursements and credit card purchases

Kittitas School District No. 403 provides educational services to approximately 610 students in kindergarten through 12th grade in Kittitas County.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's operations as well as its 76 employees. For fiscal years 2016 and 2017, the District had annual budgets of approximately \$8 million.
