AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Toledo from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting at City Hall
- Interfund loans and cost allocation plan review
- Procurement – public works and prevailing wages
- Credit card disbursements
- Open public meeting minutes
- Financial condition and fiscal sustainability

INFORMATION ABOUT THE CITY

The City of Toledo is centrally located between the Cascade Mountains and the Pacific Coast on the Cowlitz River in south central Lewis County. The City serves 725 citizens and is administered by a mayor-council form of government with five elected Council Members and an independently elected Mayor.

The City's annual expenditures were \$6.6 million in 2015 and \$1.8 million in 2016. Nine employees provide a full range of services including police, street maintenance, and general administration services. In addition, the City owns and operates water and sewer systems.
