AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Eastmont Metropolitan Parks District from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement for public works projects, purchases, and professional services
- General disbursements review and approval
- Controls over safeguarding of cash receipts

INFORMATION ABOUT THE DISTRICT

The Eastmont Metropolitan Park District was established on May 18, 2004, to provide parks and recreation services to the Greater East Wenatchee Area, which includes all of the city of East Wenatchee and parts of Douglas County. The District maintains four parks, an aquatic center and over 20 youth and adult recreational programs.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Director to oversee the District's daily operations as well as its seven full-time employees and a varying number of seasonal employees. For fiscal years 2016 and 2017, the District operated on annual budgets of approximately \$915,000 and \$973,000, respectively.
