AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, except as described below, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to City management and Council in a letter dated September 12, 2018, related to small and attractive assets. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Deer Park from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance unemployment compensation
- Cash receipting review of vision system receipt retention policies and procedures at city hall
- Payments/expenditures general disbursements review at city hall
- Safeguarding of theft sensitive assets at city hall and the city shop

INFORMATION ABOUT THE CITY

The City of Deer Park was incorporated in 1908 and currently serves more than 4,100 Spokane County residents. It provides an array of services including water and sewer utilities, streets, parks and recreation, traffic engineering, planning, economic development and general administration services. The City contracts with Spokane County for police and court services. The City is also served by Spokane County Fire Protection District No. 4 and the Spokane County Library District.

An elected, five-member Council and a separately elected Mayor govern the City. The Management oversees the City's daily operations. The City has 11 full-time and several part-time, seasonal employees. For fiscal year 2017, the City operated on an annual budget of approximately \$14 million.
