AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Port of Poulsbo from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Credit card disbursements and controls
- Marina billing and moorage tenant agreements
- Safeguarding of small and attractive assets
- Tracking of surplus property

INFORMATION ABOUT THE PORT

The Port of Poulsbo was established in 1964 and is located in Kitsap County. The Port consists of a marina with moorage of 250 permanent berths and 124 guest berths.

An elected, three-member Board of Commissioners governs the Port. The Board appoints an Executive Director to oversee the Port's daily operations as well as its six employees. The primary sources of revenue for the Port include moorage and related services, sales of fuel, property taxes and property lease/rental operations. For 2016 and 2017, the Port operated on budgets of approximately \$1.4 million and \$1.6 million, respectively.
