#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, Housing Authority operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to Housing Authority management and Board of Commissioners in a letter dated September 12, 2018, related to procurement. We appreciate the Housing Authority's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the Housing Authority of Grant County from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Housing Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Property management group contract monitoring and receipting controls
- General disbursements credit cards and employee reimbursements
- Procurement contract payments and retainage
- Payroll disbursements gross pay recalculation and leave cash outs
- Tenant billing and rent receipts

#### **Financial**

#### INFORMATION ABOUT THE HOUSING AUTHORITY

Grant County created the Housing Authority of Grant County in 1943. The Housing Authority's purpose is to provide housing assistance to families and individuals with low incomes. To accomplish this objective, the Housing Authority administers several federally and locally financed housing programs. The Housing Authority's jurisdiction encompasses all unincorporated areas within Grant County and several cities in the county under inter-jurisdictional agreements.

An elected, six-member Board of Commissioners governs the Housing Authority. The Board appoints management to oversee the Housing Authority's daily operations as well as its approximately 30 employees. For the fiscal year 2016 and 2017, the Housing Authority operated on a budget of approximately \$7.6 million and \$8.1 million, respectively.
