AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Newcastle from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Procurement compliance with public works projects awarded and prevailing wage requirements; review of change orders
- Procurement compliance with equipment purchases
- Procurement compliance and proper monitoring of police and fire services contracts
- Small and attractive assets tracking and safeguarding of theft-sensitive assets
- Credit card transactions compliance with City policy and state statutes
- State grants compliance with grant requirements

INFORMATION ABOUT THE CITY

The City of Newcastle, incorporated on September 30, 1994, currently has a population of about 11,000 citizens. It provides limited services consisting of planning and building services, public works, community development, parks and recreation, storm water management, and financial services. The City contracts with King County for police and library services. The City of Bellevue provides fire and emergency services. Coal Creek Utility District provides water and sewer services and storm water maintenance. The City operates a municipal court in conjunction with the City of Mercer Island, using the same judge and court administrator.

An elected, seven-member Council governs the City. Council Members elect one of its members to serve as Mayor. The Council appoints a City Manager to oversee the City's daily operations as well as its 26 employees. For fiscal year 2017, the City operated on an annual budget of approximately \$17.8 million.
