## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Town operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the Town of Waterville from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-Insurance – unemployment insurance budgeting
- General disbursements – review and approval
- Utility billing – account billing and payment receipting
- Procurement – public works bidding, change orders, and prevailing wage

## INFORMATION ABOUT THE TOWN

The Town of Waterville was incorporated in 1889 and currently serves over 1,175 citizens in Douglas County.

An elected, five-member Council and an independently elected Mayor govern the Town. The town had about \$1.4 million in annual revenues for fiscal years 2015, 2016, and 2017. The Town's five full-time employees provide an array of services including water, sewer, garbage, police, parks and recreation and planning.
