AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Agency operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of RiverCom 911 from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Agency's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements vendor payments
- Calculation of user fees client billing
- Payroll gross pay analysis

INFORMATION ABOUT THE AGENCY

RiverCom 911 (RiverCom) is a jointly operated 911 Communications Center located in Chelan County. It serves as the 911 Communications Center for law enforcement agencies in Chelan and Douglas counties, as well as most Fire and Emergency Medical Service agencies in Chelan and Douglas counties. RiverCom was created in October 2002 and began operating independently in July 2004.

The Board appoints a Director and an Administrative Services Manager to oversee RiverCom's daily operations as well as its approximately 40 employees. RiverCom receives revenue from the agencies it supports, the State E-911 grant fund and the Local E-911 grant excise tax. For the 2017 and 2016 fiscal year, RiverCom operated on a budget of approximately \$13.9 million and \$9.3 million, respectively.
