AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Transportation Benefit District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Arlington Transportation Benefit District from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Transportation Benefit District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements for maintenance of existing infrastructure
- Annual report filing compliance
- Assumption and dissolution of the District by the City of Arlington
- Open Public Meetings compliance

INFORMATION ABOUT THE TRANSPORTATION BENEFIT DISTRICT

On April 1, 2013, the Arlington City Council passed Ordinance 2013-005, which created a Transportation Benefit District (TBD) in the City of Arlington. A TBD is a quasi-municipal corporation and independent taxing district created for the sole purpose of acquiring, constructing, improving, providing, and funding transportation improvements within the City limits of Arlington. The city has the authority to impose certain taxes and fees, either through a vote of the people or Board action for transportation purposes. The voters approved a two-tenths of one percent sales tax that would fund repairs and improvements to the 314 road segments throughout the City that are in failing or near failing condition over the next 10 years. The District collected \$1,288,185 and \$1,224,721 in revenues for the 2016 and 2017 fiscal years, respectively. On February 20, 2018, city council adopted Ordinance 2018-001, which authorized the city to assume the rights, responsibilities, powers, and functions of the transportation benefit district. As of January 1, 2018, the District is governed by the Arlington City Council.
