AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Whatcom County Fire Protection District No. 7 from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- IT security policies, procedures, practices, and controls protecting financial systems, IT systems, and data
- Control understanding of payroll and accounts payable performed in-house
- Procurement compliance including consideration of piggybacking procedures

INFORMATION ABOUT THE DISTRICT

Whatcom County Fire Protection District No. 7 provides fire prevention and suppression and ambulance services to approximately 23,000 Whatcom County residents. The District's service area covers 75 square-miles and includes the City of Ferndale.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operation as well as its approximately 50 employees and 45 volunteers. For fiscal years 2016 and 2017, the District operated on operating revenues of approximately \$8.3 million and \$7.7 million, respectively.
