AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Skyline Hospital from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance for health and welfare benefits
- IT security practices and controls over key software applications
- Disbursements – general vender payments, employee reimbursements, and procurement cards
- Contract compliance
- Payroll – recalculation of gross wages and paid time off (PTO) cashouts
- Procurement – public works projects and professional services
- Financial condition and fiscal sustainability
- Collections on past due billings
- Tracking and monitoring of equipment and theft sensitive items

INFORMATION ABOUT THE DISTRICT

Klickitat County Public Hospital District No. 2, doing business as Skyline Hospital, owns and operates a 25-bed critical access acute care facility in Klickitat County. The District offers surgery, cardiopulmonary, radiology, laboratory, physical therapy, pharmacy and emergency services. In addition, the District operates a Skilled Nursing Facility (Swing Bed) to provide temporary transitional needs for patients that need extended care. The District provides additional services for the community through its specialty clinics, primary care clinic, and visiting physicians. Specialty clinic services currently include general surgery and ENT. Visiting physicians include podiatry and travel medicine.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 94 full-time employees, not including per diem employees. For 2016 and 2017, the District operated on an annual budget of approximately \$18.4 and \$18.9 million in net operating revenue, respectively.
