AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Burien from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement public works, prevailing wages, and change orders
- Community Center cash receipting and policy review
- Small and attractive assets controls related to inventory and asset tracking
- Open public meeting minutes
- Credit card expenditures purchases were for allowable purposes
- Financial condition and fiscal sustainability

INFORMATION ABOUT THE CITY

The City of Burien was incorporated in 1993 in King County.

An elected, seven-member Council governs the City. The Council elects one member to serve as Mayor to preside over the Council for a two-year term. The Council appoints a Manager to oversee the City's daily operations as well as its approximately 74 full-time employees.

The City of Burien serves approximately 50,680 residents. The City provides a range of services to the public, either directly or through contracts with other governmental agencies including municipal court, police, jail, public works, planning and community development, parks, recreation and cultural, library, fire, water and sewer services. In fiscal year 2017, the City's general fund operating budget was approximately \$26 million.
