AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Federal Way from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Procurement public works, professional services, and change orders
- Credit card and fuel expenditures
- Travel expenditures
- Cash-receipting and contracting policies at the Performing Arts and Event Center
- Self-insurance for property, health and welfare, and unemployment

INFORMATION ABOUT THE CITY

The City of Federal Way serves approximately 93,425 citizens in King County and is the ninth largest city in the state.

The City is administered by a mayor-council form of government. The City has seven elected Council Members and an independently elected Mayor. The City's 2017 general fund budget was \$48.2 million.

Approximately 329 full-time equivalent employees along with some temporary/seasonal help provide a range of municipal services including public safety, Municipal Court, public works, planning and community development, parks and recreation, surface water management, and general administration and support. In addition, the City owns and operates a Community Center and the Dumas Bay Centre.
