## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the City of Kenmore from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Controls over key software application
- Payroll – support for overtime pay calculations and compliance with city policy
- Procurement – compliance with public works projects awarded via alternative methods
- Permit revenues – ensure permits charged agree with permit fee schedules
- Contract and agreements – compliance with state statutes and proper monitoring of property management contracts and agreements
- Open public meetings act – statutory compliance with city planning commission minutes

## RELATED REPORTS

### **Financial**

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements. That report is available on our website, <http://portal.sao.wa.gov/ReportSearch>.

### **Federal grant programs**

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report.

## INFORMATION ABOUT THE CITY

The City of Kenmore was incorporated on August 31, 1998 and serves 22,920 citizens in King County. The City provides services including administration, engineering, planning, storm water management and land use. The Northshore Utility District provides water and sewer services and the Northshore Fire District No. 16 provides fire and emergency medical services. Police services are contracted with King County.

An elected, seven-member Council governs the City. The Council selects one of its members to serve as mayor for a two-year term. The Council also appoints a City Manager to oversee the City's daily operations as well as its 34 employees. For the 2017-2018 biennium, the City operated on a general fund budget of approximately \$23 million.
