AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Town operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Town of Almira from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements and credit card activity
- Cash receipting at Town Hall
- Procurement of public works projects and purchases
- Financial condition

INFORMATION ABOUT THE TOWN

The Town of Almira, located in Lincoln County, was incorporated in 1904. The Town provides fire protection, street improvements, parks, water, sewer, garbage and general administrative services to approximately 285 citizens.

An elected, five-member Council and an independently elected Mayor govern the District. The Town has two full-time employees and up to two part-time employees. The Town had operating revenues of approximately \$445,000, \$596,000 and \$480,000 for fiscal years 2015, 2016 and 2017, respectively.
