AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Northeast Tri County Health District from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Environmental Health and Community Health Departments – billings and collections
- Safeguarding of vaccine inventory
- Selected IT security policies, procedures, practices protecting financial system, IT systems and data

INFORMATION ABOUT THE DISTRICT

The Northeast Tri County Health District was formed in 1977 through an agreement among the cities, towns and counties of northeast Washington. The District provides public health services to approximately 65,600 residents of Ferry, Pend Oreille, and Stevens counties and in 12 incorporated communities.

An appointed, nine-member Board of Health governs the District. The Board is composed of elected officials from the cities, towns and counties in the Tri County area. The District has offices in the cities of Colville, Newport and Republic. The Board appoints management to oversee the District's daily operations as well as its 21 employees. For fiscal year 2017, the District operated on an annual budget of approximately \$2.1 million.
