AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Anacortes from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement of public works projects including Wastewater Treatment Plant Outfall project, Fiber Optic Network project and designated emergency projects
- Cash receipting Finance, Police Department and Library
- Senior Center transition of program from Skagit County and review of Foundation agreement
- Parks and Recreation cash receipting and refunds for various activities such as parks, drop-in programs and community sporting events
- Disbursements including credit card and travel expenditures

Financial

Our opinion on the City's financial statements is provided in a separate report, which includes the City's financial statements. That report is available on our website, <u>http://portal.sao.wa.gov/ReportSearch</u>.

That report includes a finding for a significant deficiency in internal controls over financial reporting regarding tax receivable activity and intergovernmental revenue.

INFORMATION ABOUT THE CITY

The City of Anacortes, incorporated in 1891, serves over 16,000 citizens in Skagit County. The City provides an array of services including water, sanitary sewer, storm sewer, solid waste, police, Municipal Court, fire prevention and suppression, emergency medical response, parks and recreation, and planning and community development. The City also operates its own library, museum and cemetery.

An elected, seven-member Council and an independently elected Mayor govern the City. The Mayor appoints, with Council confirmation, management to oversee the City's daily operations as well as its 184 full-time employees. During fiscal year 2017, the City operated on an adopted general fund budget of \$14 million.
