## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of East County Fire and Rescue from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll – recalculation of gross wages, leave accruals and leave cash outs
- Accounts payable – general disbursements, employee reimbursements, and credit cards
- Cash receipting – timeliness and completeness of deposits, voids and adjustments
- Open public meetings – documentation of meeting minutes

## INFORMATION ABOUT THE DISTRICT

East County Fire and Rescue, formerly Clark County Fire Protection District No. 9, provides fire services to approximately 10,115 residents. The District's service area covers a 60 square-mile rural residential area bordering the cities of Washougal and Camas.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's operations as well as its 18 employees and 17 volunteers. For fiscal years 2015, 2016 and 2017, the District had annual operating revenues of approximately \$2.5 million, \$2.7 million and \$2.6 million, respectively.
