AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Roslyn from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility billings and cash receipting
- Payroll – wage recalculation and overtime
- Selected IT security policies, procedures, practices, and controls protecting financial systems, IT systems, and data
- Procurement for public works projects
- Accounts payable – general disbursements including credit cards and travel

Financial

That report includes a finding for a significant deficiency in internal controls over the financial statement preparation process to ensure accurate reporting.

INFORMATION ABOUT THE CITY

The City of Roslyn serves approximately 910 citizens in Kittitas County. It is administered by a mayor-council form of government with seven elected Council Members and an independently elected Mayor.

The City operates on an approximate \$3,000,000 annual budget. Its six full-time employees provide an array of services including water and sewer utilities, fire, parks, planning and economic development. It also operates its own library system and cemetery.
