AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Lakewood from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Courts – third-party receipting
- Credit cards and accounts
- Financial condition and fiscal sustainability
- Procurement – bidding for purchases and services
- Safeguarding of small and attractive assets – citywide

INFORMATION ABOUT THE CITY

The City of Lakewood was incorporated in February 1996 and currently serves approximately 60,000 citizens in Pierce County.

An elected, seven-member Council governs the City. The Council elects one of its members to serve as Mayor. The City Manager is appointed by the Council and is responsible for the day-to-day operations of the City.

In fiscal year 2017, the City operated on budgeted revenue of \$79 million. The City's 219 employees provide a range of services including police, public works, planning and permits and certain parks and recreation services. The City contracts with public and private entities for many of its services including fire protection, certain parks and recreation services, emergency medical services, public utilities, public transportation, street maintenance and library services.
