AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Agency operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Martin Hall Juvenile Detention Facility from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Agency's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Policies and procedures – investment of surplus cash, procurement of goods and services, and small and attractive assets.
- Contracts/agreements – review of the interlocal agreement between Martin Hall and Lincoln County for compliance with laws and regulations.
- Financial condition and fiscal sustainability.

INFORMATION ABOUT THE AGENCY

The Martin Hall Juvenile Detention Facility is a maximum-security juvenile detention center located in Medical Lake. The Facility began operations in November 1997 based on an inter-local agreement between nine eastern Washington counties. The Facility creates programs and contracts for services based on the needs of the participating counties.

The Board of Directors is composed of one Commissioner from each participating county. The Board is responsible for entering into all contracts necessary for the operation of the Facility, as it has no employees. The Facility operated on an annual budget of approximately \$2 million for both 2016 and 2017.
