AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to City management and Mayor and City Council in a letter dated October 29, 2018, related to cash receipting procedures and controls at the Golf Course. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Auburn from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Cash-receipting in Utilities and Parks and Recreation departments
- Self-insurance – workers compensation
- Procurement – public works and sole source contracts
- Utility billings and adjustments
- Court payments and revenues

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal programs, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report.

INFORMATION ABOUT THE CITY

The City of Auburn, incorporated in 1891, is located primarily in southern King County and a small northeastern portion of Pierce County and has approximately 78,960 residents.

The City provides a full range of municipal services including community and economic development, a cemetery, an airport, public works, parks and recreation (including a golf course), police, and water/sewer/storm/garbage utilities.

The City operates under a mayor council form of government with seven elected Council Members and an independently elected Mayor. For fiscal year 2017, the City operated on an annual budget of approximately \$270 million.
