AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Oak Harbor from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Waste water treatment plant project monitoring of general contractor construction management procurement method
- Accounts payable general disbursements and credit accounts
- Senior Center, with a focus on travel expenditures
- Assets surplus procedures
- Utility billings implementation of rate changes
- Conflict of interest
- Police Department booking fees

INFORMATION ABOUT THE CITY

The City of Oak Harbor is located in Island County and has a population of approximately 22,200 citizens. It provides an array of services including police, fire, water, sewer, solid waste, street maintenance, planning, parks and marina operations. The City also provides water and waste water treatment to the Whidbey Island Naval Air Station.

An elected seven-member Council and a separately elected Mayor govern the City and appoint management to oversee the City's daily operations and its approximately 143 employees. The City operated on a biennial budget of approximately \$170.6 million and \$115.6 million for 2016 and 2017, respectively.
