AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Commissioners in a letter dated November 8, 2018, related to procurement. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Yakima County Fire Protection District No. 5 from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement including purchases and piggybacking
- Self-insurance for unemployment compensation
- Payroll including timesheet calculations and approvals
- Dispatch service billings
- Fuel card expenditures

INFORMATION ABOUT THE DISTRICT

Yakima County Fire Protection District No. 5 provides fire protection and prevention services to the unincorporated areas of the lower Yakima County. The District has 15 fire stations that cover its approximately 750 square-mile service area.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as its 19 full-time employees and approximately 180 volunteers. For the years under audit, the District operated on annual budgets of approximately \$3,200,000.
