AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Stilly Valley Health Connections from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Account payable including credit cards and travel expenditures
- Payroll including leave and benefits
- Safeguarding of assets including surplusing procedures

INFORMATION ABOUT THE DISTRICT

Public Hospital District No. 3, Snohomish County, was created in 1964 to provide hospital and emergency services in the northeastern portion of Snohomish County (serving the cities of Arlington and Darrington).

Until June 2016 the District operated as Cascade Valley Hospital and Clinics, which included a 48-bed hospital facility, five medical clinics, and a freestanding ambulatory surgery center. The District entered into a 30-year lease for the hospital and clinics to be operated by Skagit County Public Hospital District No. 1, which does business as Skagit Regional Health.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Superintendent to oversee the District's daily operations including a staff of three persons. Operating revenues for the District were approximately \$20,530,000 for 2016 and \$3,141,000 for 2017.
