## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of South Bay Fire Department from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement – purchases through cooperative
- Tracking and monitoring of theft sensitive assets
- Open public meeting minutes
- Financial condition and fiscal sustainability

## INFORMATION ABOUT THE DISTRICT

Thurston County Fire Protection District No. 8, doing business as South Bay Fire Department, was created in 1953. The District provides fire suppression and emergency medical services for the residents within its 31.4 square-mile boundary in Olympia.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as its 12 full-time employees, five firefighters, three fire lieutenants, and approximately 75 volunteer firefighters. The District is funded through property taxes levied by the County. Operating expenditures for the District were approximately \$2.4 million in 2015, \$2.4 million in 2016 and \$2.6 million in 2017.
