AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Roy from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial reporting
- Open public meetings
- Financial condition and City sustainability
- Interfund loans – repayment of the loans
- Courts – cash receipting and record keeping
- Procurement/credit cards – purchases and controls for the cards
- Procurement – Public works bid law compliance
- Small & attractive assets – reviewing controls and asset inventory

INFORMATION ABOUT THE CITY

The City of Roy is located in Pierce County and serves approximately 820 citizens. The City provides an array of services including police protection, Municipal Court, street improvements, water services, parks and recreation and library services.

An elected, five-member Council and an independently elected Mayor govern the City. Council Members serve staggered, four-year terms. The Council appoints management to oversee the City's daily operations. The City has ten employees, six of which are less than one full-time employee. For 2016 and 2017, the City's expenditures were \$858,343 and \$1,149,538, respectively.
