AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Pomeroy from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting and deposits
- Third party receipting
- Interfund loans – use of Cemetery Endowment Fund and Solid Waste Reserve Fund
- Interlocal agreements – review of deliverables of agreement with County Sheriff and Courts
- Financial condition and fiscal sustainability

INFORMATION ABOUT THE CITY

The City of Pomeroy is the only incorporated city in Garfield County, serving approximately 1,500 citizens. The City has a mayor-council form of government with a five-member Council and an independently elected Mayor.

The City provides services including water, sewer, streets maintenance, cemetery, pool, library, golf course and general administration. For fiscal years 2015, 2016 and 2017 the City received annual operating revenue of \$1.5 million, \$1.8 million and \$1.5 million, respectively.
