#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Commissioners in a letter dated December 4, 2018 related to utility late fees and the procurement of purchases and architectural and engineering services. We appreciate the District's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of East Spokane Water District No. 1 from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utilities fees, waivers, cash-receipting and billing
- Procurement public works, prevailing wages and purchases
- Tracking and monitoring of theft sensitive assets
- Financial condition and fiscal sustainability

### INFORMATION ABOUT THE DISTRICT

East Spokane Water District No. 1 was formed in 1917 and currently provides water services to approximately 1,200 customers in an area covering 2.75 square-miles in central Spokane Valley.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its four employees. For fiscal years 2015, 2016 and 2017, the District operated on budgets of approximately \$696,000, \$664,000 and \$739,000, respectively.
