AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Port of Shelton from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Industrial leases billing and cash receipting
- Procurement public works and professional services
- Financial condition and fiscal sustainability
- Open public meetings compliance
- Controls over state grants
- Tracking and monitoring of theft sensitive assets

INFORMATION ABOUT THE PORT

The Port of Shelton was incorporated in 1948 and is supported through taxes, user fees and grants. The Port operates the Shelton Marina, Sanderson Airfield and adjacent industrial complex, and the Johns Prairie industrial site.

An elected, three-member Commission governs the Port. The Board appoints an Executive Director to oversee the Port's daily operations as well as its nine employees. For the year ended December 31, 2017, the Port had annual revenues of approximately \$3.7 million.
