#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Commissioners in a letter dated November 29, 2018, related to disbursements. We appreciate the District's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the Samish Water District from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Disbursements retroactive pay, bid compliance and credit card transactions
- Billing revenue and adjustments

### INFORMATION ABOUT THE DISTRICT

The Samish Water District provides sewer services to approximately 470 residential customers and 30 commercial customers in Whatcom and Skagit Counties. The District's service area includes Lake Samish to the Samish River Basin, including the Cain Lake area in Whatcom County and along Old Highway 99 North Road to the city of Burlington in Skagit County.

An elected, three-member Board of Commissioners governs the District. The Board appoints a District Manager to oversee the District's daily operations as well as its three employees. The District is funded primarily through fees charged for sewer service and connections. The Districts revenues were \$956,072 in 2015, \$1,035,054 in 2016 and \$1,038,298 in 2017.
