AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Metropolitan Park District of Tacoma from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting Boathouse Marina, Kandle Pool, Fort Nisqually and Portland Avenue Community Center
- Bond compliance
- Procurement cards
- Procurement Public Works projects and disbursement testing

INFORMATION ABOUT THE DISTRICT

The Metropolitan Park District of Tacoma was created in 1907, by a vote of the people, to operate parks and recreation facilities. Its boundaries include the city of Tacoma and areas of Browns Point and Dash Point. The District currently administers numerous sites including Point Defiance Park, Seymour Conservatory, Tacoma Nature Center, Point Defiance Zoo and Aquarium, Northwest Trek Wildlife Park, Fort Nisqually, Boathouse, Meadow Park Golf Course and many neighborhood parks. As of 2017, the District is constructing the Eastside Community Center.

An elected, five-member Board of Commissioners governs the District. Commissioners serve staggered, six-year terms. The Board appoints an Executive Director to oversee the District's daily operations as well as its approximately 301 full-time and 800 part-time/seasonal employees. The District operated on \$45 million in revenues.
