#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Authority operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of Valley Regional Fire Authority from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance unemployment
- Fire benefit charge
- Payroll overtime
- Financial condition and fiscal sustainability

## INFORMATION ABOUT THE AUTHORITY

The Valley Regional Fire Authority was incorporated on January 1, 2007, as a result of a ballot proposition. The Authority joined existing resources from the Auburn and Pacific Fire Departments to provide fire services to the communities of Algona, Auburn and Pacific. The three participating cities combined into the Valley Regional Fire Authority in an effort to reduce costs and increase coverage. The Authority provides fire protection, emergency medical aid, hazardous materials response and fire investigation services to approximately 85,000 citizens.

The Authority has a nine-member Board of Governance. For 2017, the Authority operated on a \$22.5 million operating budget and had 123 full-time employees.
