## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of King County Water District No. 111 from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement – Public Works Projects: emergency projects and on-call contracts.
- City of Kent franchise fees – billings
- Policy review – meals with meetings

## INFORMATION ABOUT THE DISTRICT

King County Water District No. 111 provides water to approximately 5,900 connections in its service area, which covers primarily incorporated areas surrounding Lake Meridian, east of the city of Kent in King County. The District supplies approximately half of its water needs from its own well and blends this with water purchased from the city of Covington, while continuing to develop its own wells.

The District has nine full-time employees and an operating budget of approximately \$4.3 million. An elected, three-member Board of Commissioners has oversight responsibility for the District. The Board approves the operating budget and reviews all District expenses. It appoints a General Manager to oversee daily operations.
