AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Walla Walla Transportation Benefit District from January 1, 2015 through August 24, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 24, 2017 and December 31, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements
- Dissolution of entity

INFORMATION ABOUT THE DISTRICT

The District is a City of Walla Walla 10-year transportation improvement program established in 2012 by a voter approved 0.2 percent sales tax increase. The District collects funds for transportation improvement projects. The District does not have any employees. All the expenditures are paid by the City and then the City bills the District for the cost.

A seven-member Board of Directors governs the District. District revenues were \$1,137,124, \$1,253,098 and \$816,020, in 2015, 2016 and 2017, respectively. On August 24, 2017, the District was assumed by the City of Walla Walla.
