AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Town operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Town of Bucoda from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance for unemployment
- Cost allocation – equitable distribution of indirect costs
- Restricted funds – Community Development Block Grant funds
- Procurement – bidding for public works projects
- Utilities – verification of billing rates and accuracy of billing calculations
- Financial condition and fiscal sustainability
- Payroll – recalculation of gross wages
- Open public meeting minutes

INFORMATION ABOUT THE TOWN

The Town of Bucoda, located in Thurston County, was incorporated in 1910 and currently has a population of approximately 560. The Town provides its citizens, directly or through contract, services including public safety, fire prevention, refuse collection, street improvements, parks and recreation and general administrative services. In addition, the Town operates a water system and a recreational campground.

An elected, five-member Council and a separately elected Mayor govern the Town. For fiscal year 2016 and 2017, the Town operated on annual budgets of approximately \$3,544,000 and \$523,000, respectively. The Town had two full-time employees for the duration of fiscal years 2016 and 2017, with one part-time employee hired as seasonal help in 2016, and two part-time employees hired as seasonal help in 2017.
