## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Stevens County from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility subsidization – cost allocation between utility systems
- Cash receipting – water and sewer payments
- Credit cards – fuel cards and travel expenditures and reimbursements
- Safeguarding of small and attractive assets at District locations
- Vehicle use policy

## INFORMATION ABOUT THE DISTRICT

Stevens County Public Utility District No. 1 is located in the unincorporated town of Loon Lake and provides services to residents in Stevens County and parts of northern Spokane County. The District operates 17 water systems serving approximately 4,846 customers and seven sewer systems serving approximately 1,476 sewer customers. The District also owns and operates a Septage Reuse Facility, which processes septic material and injects it into the earth as fertilizer and soil conditioner.

A three-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its 14 employees. For the years under audit, the District operated on annual expenditures of approximately \$3.3 million for 2016 and \$3.5 million for 2017.
