#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Kitsap County from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Subsidization between utility systems
- Self-insurance unemployment
- Utility billing adjustments
- Credit card and petty cash disbursements
- Procurement public works projects

### INFORMATION ABOUT THE DISTRICT

Public Utility District No. 1 of Kitsap County provides an array of services including management of over 55 water systems owned by the District. The District repairs water systems and provides education on water resource planning and conservation. In all, the District provides some level of domestic water service to over 16,000 customers. In addition, the District operates a high-speed open access fiber optic network called KPUD Fiber, and has installed over 200 miles of broadband telecommunications throughout the county. The District works with retail service providers to provide state-of-the-art connectivity opportunities for residents, including Internet, video, telephone and other diverse business services.

An elected, three-member Board of Commissioners governs the District. The Board appoints a General Manager to oversee the District's daily operations as well as its approximately 55 employees. Its main sources of revenue include water usage fees, property taxes and wholesale telecommunications services. The District operated on annual revenues of almost \$12.5 million and \$12.2 million for fiscal years 2017 and 2016, respectively.
