ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Town of Oakesdale for January 1, 2007, through December 31, 2008.

We evaluated internal controls and performed audit procedures on the activities of the Town. We also determined whether the Town complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit:

- Cash receipting
- Compliance with grant requirements
- Budget compliance

- Disbursements/expenditures
- Payroll/personnel
- Restricted funds

RESULTS

In the areas we examined, the Town's internal controls were adequate to safeguard public assets. The Town also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE TOWN

The Town of Oakesdale was incorporated in 1888 and currently serves 420 citizens in Whitman County. The Town has three full-time employees who provide police, water, sewer, street and general administrative services. An elected, five-member Council and an independently elected Mayor govern the Town. For fiscal years 2007 and 2008, the Town operated on budgets of approximately \$486,000 and \$834,000, respectively.

AUDIT HISTORY

Typically we audit the Town once every two years. A finding was issued in 2003 for lack of internal controls and misappropriation of funds. This finding has been resolved and we have not reported any findings since that time.
