ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Water District No. 19 for the period from January 1, 2006, through December 31, 2008.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Cash receipting
- Procurement (bidding/prevailing wage)
- Open public meetings/records laws
- Payroll/personnel
- Petty cash/imprest account

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE DISTRICT

Water District No. 19 was established in 1925 to provide a safe water supply for the residents of Vashon Island. The District is the only public water system on Vashon, serving 1,440 customers within six square-miles of the central eastern portion of the Island. An elected three-member Board of Commissioners governs the District. Board Members are elected to serve staggered, six-year terms. The District has five full-time employees and one part-time employee. The District has a moratorium on new hookups that is not expected to end in the foreseeable future. The District collects approximately \$1 million annually in water utility revenue. District expenditures were \$691,204.41 for 2006, \$752,811.35 for 2007 and \$813,763.37 for 2008.
