#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Joint Animal Services for January 1, 2007, through December 31, 2008.

We evaluated internal controls and performed audit procedures on the activities of the Agency. We also determined whether the Agency complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit:

- Cash receipting
- Disbursements
- Payroll

- Bid law compliance
- Open Public Meetings Act

#### **RESULTS**

In the areas we examined, the Agency's internal controls were adequate to safeguard public assets. The Agency also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### ABOUT THE AGENCY

The Joint Animal Services was created through an inter-governmental agreement between Thurston County and the cities of Lacey, Olympia and Tumwater to provide animal control and related services to their residents. The city of Lacey is the lead agency and provides administrative support and financial management.

The Agency is governed by a six-member Board of Commissioners. The Board is comprised of one Commissioner from each of the participating governments, one licensed veterinarian practicing in Thurston County and one at-large member representing the Thurston County Humane Society. For fiscal years 2007 and 2008, the Agency operated on annual budgets of \$1.5 million and \$1.6 million, respectively. The Agency has approximately 17 employees and 56 volunteers.
