#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Whatcom County Fire Protection District No. 4 from January 1, 2008 through December 31, 2009.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Cash receipting
- Debt covenants
- Open Public Meetings Act
- Property acquisition and sale

- Facility rentals
- Awards banquets
- Expenditures
- Revenue

#### **RESULTS**

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### ABOUT THE DISTRICT

Whatcom County Fire Protection District No. 4 serves approximately 9,000 residents in an area covering approximately 36 square-miles of Whatcom County. The District provides fire prevention, suppression and emergency rescue services.

An elected, three-member Board of Commissioners governs the District. The Board appoints management to oversee its seven full-time employees and over 50 volunteer firefighters. For 2008 and 2009, the District operated on annual budgets of approximately \$2 million.

#### **AUDIT HISTORY**

We audit the District every two years. The past four audits of the District have reported two areas of concern. The 2004-2005 audit contained a finding involving a severance payout to the former Fire Chief and the 2002-2003 audit contained a finding involving a conflict of interest issue. These issues have been resolved.
