Audit Summary

ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Seattle Chinatown International District Preservation and Development Authority from January 1, 2011 through December 31, 2011.

We evaluated internal controls and performed audit procedures on the activities of the Authority. We also determined whether the Authority complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Open Public Meetings Act
- Payroll/personnel
- Expenditures and credit card use
 Rights and obligations
- Procurement requirements

RESULTS

In most areas, the Authority complied with state laws and regulations and its own policies and procedures.

However, we noted certain matters that we communicated to Authority management. We appreciate the Authority's commitment to resolving those matters.

Description of the Authority

ABOUT THE AUTHORITY

The Seattle Chinatown International District Preservation and Development Authority was established by a charter issued by the city of Seattle on December 16, 1975. The purpose of the Authority is to preserve, promote and develop the Seattle Chinatown-International District as a vibrant community and unique ethnic neighborhood.

The Authority owns or manages 353 low-income residential units and 130,000 square feet of commercial and retail space. The majority of the residential properties provide low-income housing. The most significant properties are:

- Bush Annex, which houses the Northwest Asian America Theater.
- Legacy House, which provides multi-cultural senior housing and services.
- International District Village Square, which provides centralized resources for health care, mental health, social services, pre-school and child care, employment services, senior advocacy, supportive care and housing.
- IDEA Space, which serves as a catalyst for responsible neighborhood investment and a vehicle for strengthening community involvement in revitalization efforts.

The Authority is governed by a Council of up to 17 members. The Mayor of the city of Seattle appoints four members; the constituency of the Authority elects four members, the Authority's Council elects four members and an additional one to five members as selected by the Council. All members of the Authority's Council are confirmed by the Seattle City Council. The City does not consider the Authority to be a component unit. The Authority is supported primarily through service agreements and rental income. The Authority's 2011 operating revenue was approximately \$6 million and it had approximately 102 employees.

AUDIT HISTORY

We audit the Authority annually. In 2010 we reported a finding that the Authority exceeded its statutory authority by investing in an unallowable interest rate swap. The Authority disagreed with this finding, but agreed to consult a financial advisor to ensure compliance with state laws when entering into financial transactions. In 2008 we reported a finding that the Authority had awarded additional compensation to an employee and had inadequate controls over employee leave balances. The Authority resolved these issues.

Status of Prior Audit Findings

The status of findings contained in the prior years' audit reports of the Authority is provided below:

1. The Authority exceeded its statutory authority by entering into an unallowable interest rate swap.

Report No. 1007270, dated January 26, 2012

Background

In 2007 the New Central Hotel, a limited liability company in which the Authority owns a majority interest, entered into an interest rate swap to mitigate the risk that its financing would not be adversely affected by changes in interest rates.

State law allows certain local governments to engage in interest rate swaps. The Authority is not one of those governments.

We recommended the Authority establish procedures, such as consulting with a financial advisor, to ensure compliance with state law when entering into financial transactions.

Status

The Authority disagrees with the finding. However, the Authority agreed to consult with a financial advisor to ensure compliance with state law when entering into financial transactions. This issue is resolved.
