Audit Summary

Seattle Chinatown International District Preservation and Development Authority King County December 5, 2013

ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Seattle Chinatown International District Preservation and Development Authority from January 1, 2012 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the Authority. We also determined whether the Authority complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Service agreements controls and compliance
- Open public meeting minutes
- General disbursements
- Procurement of public works and purchases

RESULTS

In most areas, the Authority complied with state laws and regulations and its own policies and procedures.

However, we noted certain matters that we communicated to Authority management. We appreciate the Authority's commitment to resolving those matters.

FINANCIAL AND GRANT COMPLIANCE

A financial statement and federal grant compliance audit was performed by a firm of certified public accountants. That firm's report is available from the Authority. The firm reported a material weakness in internal controls over its federal award Section 8 New Construction/Substantial Rehabilitation regarding funds that were improperly distributed and advanced to a related party by two of the Authority's component units. Related to that issue, the firm reported questioned costs in the amount of \$32,957. The firm's report also notes that these two issues were corrected prior to the issue date of the firm's report.

ABOUT THE AUTHORITY

The Seattle Chinatown International District Preservation and Development Authority was established by a charter issued by the city of Seattle on December 16, 1975. The purpose of the Authority is to preserve, promote, and develop the Seattle Chinatown-International District as a vibrant community and unique ethnic neighborhood. The Authority owns or manages 434 low-income residential units and 200,000 square feet of commercial and retail space. The residential properties provide low-income housing. The most significant properties are:

- Bush Annex, which houses the Theater Off Jackson.
- Legacy House, which provides multi-cultural senior housing and services.
- International District Village Square, which provides centralized resources for comprehensive health care, pre-school and childcare, supportive care and housing for seniors, as well as the local branch of the Seattle Public Library, City of Seattle Parks Department's International District/Chinatown Community Center and housing for low income families.
- IDEA Space, which serves as a catalyst for responsible neighborhood investment and a vehicle for strengthening community involvement in revitalization efforts.

The Authority is governed by a Council of up to 17 members. The Mayor of the city of Seattle appoints four members, the constituency of the Authority elects four members, the Authority's Council elects four members and an additional one to five members as selected by the Council. All members of the Authority's Council are confirmed by the Seattle City Council. The city does not consider the Authority to be a component unit. The Authority is supported primarily through service agreements and rental income. The Authority's 2012 operating revenue was approximately \$6 million. It has approximately 102 employees.

AUDIT HISTORY

We audit the Authority annually. In 2011, we communicated to management that the Authority was not in compliance with the open public meetings act when they voted to approve a grant application via email. By conducting business via email, the Council denied the public the opportunity to hear the Council deliberate and take action in an open public meeting. The Authority resolved this issue. In 2010 we reported a finding that the Authority exceeded its statutory authority by investing in an unallowable interest rate swap. The Authority disagreed with this finding, but agreed to consult a financial advisor to ensure compliance with state laws when entering into financial transactions.



ABOUT THE STATE AUDITOR'S OFFICE
