### **Whistleblower Investigation Report**

#### State of Washington Employment Security Department

#### ASSERTION AND RESULTS

Our Office received a whistleblower complaint asserting an Employment Security Department employee recycled state property for his personal financial gain.

We found no reasonable cause to believe an improper governmental action occurred.

#### ABOUT THE INVESTIGATION

In September 2013 the Employment Security Department (Department) relocated its Seattle office to Lacey. Pursuant to City code the Department was required to remove telecommunication wiring from the Seattle office. In September 2013 the Department entered into a contract to have this work completed.

We interviewed the contractor who stated their company removed and disposed of the wire from the Seattle office. We also interviewed a Department contract specialist who stated that, in most cases, contractors will retain wiring after removal, recycle it and use the proceeds to offset their costs.

#### STATE AUDITOR'S OFFICE REMARKS

We thank Department officials and personnel for their assistance and cooperation during the investigation.

### **Whistleblower Investigation Criteria**

#### State of Washington Employment Security Department

We came to our determination in this investigation by evaluating the facts against the criteria below:

RCW 42.52.160 Use of persons, money, or property for private gain.

(1) No state officer or state employee may employ or use any person, money, or property under the officer's or employee's official control or direction, or in his or her official custody, for the private benefit or gain of the officer, employee, or another.
