ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Olympic View Water and Sewer District from January 1, 2011 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

ABOUT THE DISTRICT

The Olympic View Water and Sewer District was incorporated in 1937 and is located in the city of Edmonds. The District serves approximately 4,700 customers in the town of Woodway, city of Edmonds and the neighboring unincorporated portions of Snohomish County. In 1998 the District completed construction of its Deer Creek Water Treatment Plant. During the audit period, the Deer Creek Water Treatment Plant supplied an average of 41 percent of the District's water. It purchased the remaining 59 percent from the city of Seattle.

An elected, three-member Board of Commissioners governs the District. A staff of 13 employees handles the daily duties of the District. The District's operating expenses for fiscal years 2011 and 2012 were \$3,451,256 and \$3,802,408, respectively.
